The following text is taken from the NFKPC Constitution. Please take the time and read the job descriptions. Please consider holding a position. It really is only to January J

President

He/she shall preside at all regular and special meetings of the Association. He/she shall enforce observance of the constitution and by-laws, and decide all questions of order, sign all official documents, and perform other customary duties pertaining to the office of President. He/she shall be, by virtue of his/her office, Chairman of the Board of Directors and shall likewise preside at all Board meetings. He/she shall appoint all committee Chairpersons with approval of the Board of Directors, and shall be an ex-officio member of all committees. The committee Chairperson may in turn, appoint committee members he/she may need to operate his/her committee properly, and may include non-Association members on said committee, based on potential contributions to the projects at hand, subject to the approval of the President. The President shall have such powers as may be reasonably construed to belong to the chief executive of any organization and, in addition shall have such additional special powers as the Board of Directors may designate.

Vice-President

He/she shall, in the event of absence or inability of the President to exercise his/her official duty, become acting President of the Association with all rights and powers that the President possesses. He/she shall be responsible for the physical assets of the Association (show equipment, projector, etc.), and shall keep an accurate inventory including whereabouts of all said physical assets.

Secretary

He/she shall record and keep the minutes of all meetings and maintain all correspondence and records of the Association in appropriate books, and at each general membership meeting shall read the minutes of the last Board meeting. He/she shall cause to be mailed all required notices to members of the Association. He/she shall present to the Board of Directors and then to the general membership all correspondence of the NFKPC. He/she shall keep the constitution and bylaws of this Association, and have the same in his/her possession at every regular and special meeting of the general membership and the Board of Directors.

Treasurer

He/she shall keep all Association financial records and accounts, including all receipts and disbursements. He/she shall give a treasurer's report at each general membership and Board meeting. Upon approval by a majority vote of the Board of Directors, he/she shall make payment for operational expenses. He/she shall prepare an annual budget for submission at the February Board of Director's meeting, followed by the March general membership meeting for approval by the general membership.

Composition

The Board of Directors shall consist of all the Officers, and five (5) Directors. These positions, like the Officers, are elected by the Association at its annual general membership election meeting.

Meetings

Meetings of the Board of Directors will be held on a monthly basis during at least each month in which a regular meeting is held. A majority of the members (5) shall constitute a quorum and the Board may make such rules covering its meetings, as it deems necessary. These meetings are chaired by the President. In the absence of the President, the Vice-President shall serve as chair in accordance with Article 6, Paragraph B.

Powers

The Board of Directors shall control and manage the affairs and business of the Association. The Board shall act in the name of the Association at any regularly scheduled Board meeting, or whenever it has been convened by the President after due notice to all Directors. However, any action of the Board may be nullified at the first general membership meeting after the membership has been notified of such action, by a vote of either 3/4 of the voting members in good standing present at such meeting or a majority of all voting members of the Association in good standing, whichever shall be greater.

If you have any questions do not hesitate to call any present officer or board member to get an answer.
